# New CCSD Bus Barn Location is being considered for Floyd Hill –

#### Transportation & Maintenance Facility Site Search

This past year our Facilities Team researched a number of possible sites for the new bus barn, aka new Transportation & Maintenance Facility. The team presented the findings at a recent Board of Education meeting, narrowing the focus to two sites: Floyd Hill and the track at Building 103 (former middle school in Idaho Springs). We welcome community feedback!

Site 1: Floyd Hill offers proximity to the middle & high school, as the facility could be built to the north of the high school parking lot, (I70 side) and east of the wastewater treatment plant. Currently the team is investigating the site work/leveling that would need to be completed as well as water & utility needs. There are wonderful things about this site, such as the possibility of a vocational classroom or two being located in the facility. There are also big challenges, including water accessibility. One question: how would residents of Floyd Hill feel about the buses being located on this site?

While we aren't sending out a survey, we strongly encourage our community to share their thoughts & questions regarding the possible sites for the Transportation & Maintenance Facility. 
